



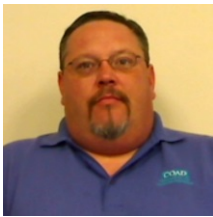
Training Professionals

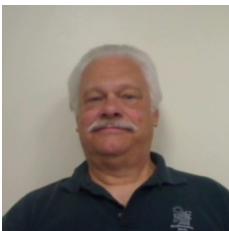
